57th WCCC YOUTH APPLICATION

To compete at the WCCC, a youth cook must be between the ages of 6 and 17 years old and have parental consent. Registration fee is \$25 and is due with application.

Youth cooks must prepare Traditional Red with adult supervision - not adult participation. There will be separate judging tables for each age category and judging will follow ICS judging criteria.

- A. Adult may help with knifework and prep, during prep ONLY.
- B. Youth must not leave their lit stove unattended if leaving the cooking area.
- C. Adult assistance **MUST STOP** once the 3-hour cooking time starts. At that time, adults are there to supervise only and assist with any safety concerns (i.e. moving heavy or hot items, etc)
- D. Adults cannot taste the youth's chili, this is their time to shine and make their own cooking decisions. Youth cooks may have other youth ages 17 and under taste their chili.

ICS VOLUNTARY YOUTH WCCC AGREEMENT AND RELEASE

I, _____, the child, and I, _____, the parent/legal guardian of the child, desire to voluntarily participate in the 57th ICS WCCC ("World Championship Chili Cook-off"). In connection with my participation in the WCCC, I acknowledge, represent, warrant and agree as follows:

- (1)** I will be at least 6 years of age as of the date of this submitted application or not more than 17 years of age, and I am a citizen or legal permanent resident of the United States.
- (2)** I and my parent/legal guardian understand and agree that my participation in the WCCC may result in the revelation, disclosure or distribution of information which may or may not be deemed confidential in nature.
- (3)** I will follow all rules and directions given by ICS/WFC Holdings, LLC., and all ICS/WFC Holdings, LLC. approved rules and directions given by representatives of ICS and WFC Holdings, LLC. sanctioned events.
- (4) MY PARTICIPATION IN THE WCCC IS AT MY OWN RISK.** I RELEASE, DISCHARGE AND HOLD HARMLESS ICS and WFC HOLDINGS, LLC., EACH OF THEIR RESPECTIVE PARENT, SUBSIDIARY AND AFFILIATED COMPANIES, LICENSEES, SUCCESSORS, AND ASSIGNS, AND EACH OF THEIR RESPECTIVE OFFICERS, DIRECTORS, AGENTS, REPRESENTATIVES AND EMPLOYEES, AND ALL OTHERS CONNECTED WITH THE ICS and WFC HOLDINGS, LLC. (INCLUDING, WITHOUT LIMITATION, VENDORS, SUPPLIERS, SPONSORS, ADVERTISERS, LICENSEES, PRODUCT INTEGRATION PARTNERS, AND TRADEOUT PARTNERS) (COLLECTIVELY, THE "RELEASED PARTIES"), FROM AND AGAINST ANY AND ALL CLAIMS, ACTIONS, DAMAGES, LIABILITIES, LOSSES, COSTS AND EXPENSES, IN ANY WAY ARISING OUT OF OR RESULTING FROM MY PARTICIPATION IN THE WCCC, INCLUDING, WITHOUT LIMITATION, ANY AND ALL CLAIMS, ACTIONS, AND LIABILITIES FOR INJURY, LOSS OR DAMAGE TO ME, TO ANYONE ELSE OR TO ANY PROPERTY, REGARDLESS OF WHETHER OR NOT SUCH INJURY, LOSS OR DAMAGE WAS CAUSED BY THE NEGLIGENT, WILLFUL, OR RECKLESS MISCONDUCT OF ANY OF THE RELEASED PARTIES. I AGREE TO DEFEND AND INDEMNIFY THE RELEASED PARTIES AND HOLD THEM HARMLESS FROM ANY AND ALL LIABILITIES, CLAIMS, ACTIONS, DAMAGES, EXPENSES AND LOSSES (INCLUDING, WITHOUT LIMITATION, ATTORNEYS' FEES) OF ANY KIND OR NATURE WHATSOEVER IN ANY WAY CAUSED BY OR ARISING OUT OF MY PARTICIPATION IN THE WCCC, A BREACH OR ALLEGED BREACH OF ANY OF MY COVENANTS, REPRESENTATIONS OR WARRANTIES HEREIN, OR THE EXPLOITATION OF ANY OF THE RIGHTS I HAVE GRANTED TO ICS and WFC Holdings, LLC.
- (5)** I understand and agree that any and all material ("Material") I provide to ICS and WFC Holdings, LLC. in connection with the WCCC and/or that ICS and WFC Holdings, LLC. creates during the WCCC shall remain the sole property of ICS and WFC Holdings, LLC. and will not be returned to me. I further understand and agree that ICS and WFC Holdings, LLC. shall have the right to record me at ICS/WFC Holdings, LLC. activities and use (and to license or assign to others the right to use) my name, voice, likeness, appearance, biographical information, recipes, any information or Material provided by me, and any motion or still pictures or video or audio recordings ICS and WFC Holdings, LLC. takes of me, in any and all media now known or hereafter devised, throughout the world in perpetuity, and that ICS and WFC Holdings, LLC. shall have these rights. I acknowledge and agree that ICS and WFC Holdings, LLC. shall own all rights (including, without limitation, all copyrights) in and to the Material. Without limiting any other release I have provided herein, I hereby release the Released Parties from any and all claims, actions, damages, liabilities, losses, costs and expenses arising out of or resulting from Producer's exercise of its rights under this paragraph.
- (6) MANDATORY ARBITRATION.** IF ANY CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN THE CITY OF VENTURA. THE ARBITRATION RULING SHALL BE FINAL AND BINDING AND SHALL NOT BE SUBJECT TO APPEAL OR CHALLENGE.
- (7)** This Agreement shall be construed and governed by the laws of the State of Tennessee.

(8) LIMITATION OF REMEDIES. I ACKNOWLEDGE THAT MY REMEDY FOR ANY CLAIM BROUGHT PURSUANT TO THIS AGREEMENT OR ARISING OUT OF MY PARTICIPATION IN THE WCCC SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL I BE ENTITLED TO RECOVER PUNITIVE OR EXEMPLARY DAMAGES OR TO RESCIND THIS AGREEMENT. IN NO EVENT SHALL I BE ENTITLED TO SE OR OBTAIN INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. I UNDERSTAND THIS AGREEMENT IS IRREVOCABLE. NOTWITHSTANDING ANYTHING TO THE CONTRARY HEREIN, NOTHING IN THIS AGREEMENT OR IN ANY OF THE APPLICABLE RULES OF JAMS SHALL PREVENT PRODUCER AND/OR NETWORK FROM SEEKING PROVISIONAL RELIEF OUTSIDE OF ARBITRATION, INCLUDING, BUT NOT LIMITED TO, EQUITABLE AND/OR INJUNCTIVE RELIEF PENDING THE ARBITRATOR'S FINAL DECISION.

(9) The illegality, invalidity or unenforceability of any provision of this Agreement shall in no way affect the validity or enforceability of any of the remainder of this Agreement, which shall be enforced to the maximum extent permitted by law.
